

### LIBER ANNUAL CONFERENCE SURVEY LONDON, 2015

### **Key Findings**

Thank you to everyone who participated in our 2015 conference survey. 32% of the c. 450 delegates gave us feedback on LIBER 2015. The main findings of the survey are listed below and will be used to improve the <u>2016 Annual Conference</u> in Helsinki, Finland.

Overall you were pleased with the Annual Conference. 92% rated the conference as 'good' or 'very good, and the parallel sessions were rated as 'good' or 'very good' by approximately 90% of attendees.

The highest ranking keynote speech 'Science and the Library in the 21st Century' was given by Sir Mark Walport, Chief Scientific Adviser to HM Government and Head of the Government Office for Science. <u>Watch it on Youtube</u>.
