PROPOSAL TO INDEX PARTICIPANTS FEES PER 2023

Approved by LIBER's Annual Meeting of Participants on 7 July 2022 in Odense, Denmark

INTRODUCTION

In 2019, the Meeting of Participants voted to strengthen LIBER's financial stability conform the proposal "[Ensuring LIBER's Viability & Building on Success](#)". In light of this, LIBER was able to adapt its financial model and offer additional services to Participants without further raising the Fees. As part of the abovementioned proposal, it was decided that LIBER would not further increase Participant Fees until 2022 – the end of the current strategic period.

INDEXING PARTICIPANT FEES

As agreed, the Annual Participant Fees have not been adjusted for inflation since they were raised after the 2019 Meeting of Participants. Over the past year, LIBER has seen a rapid increase in inflation in the Netherlands and service providers have been raising their rates for 2022 accordingly.¹ This has forced the Executive Board to re-examine the Participant Fees for 2023. Although LIBER is reluctant to raise its Annual Fees - partly in view of the current economic outlook - LIBER sees a need to correct its Fees for inflation and therefore proposes to begin indexing its Participant Fees to meet rising operational costs.

INDEXING PROPOSAL

The Executive Board suggests to index the Fees by using the [consumer price index](#) that is calculated month by month by the Dutch Central Bureau for Statistics (CBS). The index is based on each month's inflation level in the Netherlands combined with the index for that same month of the previous financial year.

Following the CBS price index for October 2021, the Executive Board agreed to adjust the Participants Fees by 3.4% for 2023.² Going forward, each year during the month of October, the Executive Board will re-examine the Fees and index them accordingly.

Note that the transparency of LIBER's financial model, with a distinction in categories based on national GDP per capita, will be maintained.

TIMELINE

In November 2021, in accordance with LIBER's [Rules & Regulations](#),³ Participants were notified of the Executive Board's intention to review the current Annual Fees in 2022. The proposal to index the 2023 Annual Fees by 3.4% was then approved by the LIBER Executive Board in February 2022. It was shared with the LIBER Network in March and May 2022 ahead of the Meeting of Participants on 7 July 2022, where LIBER Participants formally approved this proposal. Therefore, Fees will be indexed from October 2022 on, and the adjusted Fees as mentioned below will come into force on 1 January 2023. The LIBER website was updated to reflect the proposal's approval and Participants will receive additional notifications of the changes in the August and November 2022 Quarterly Mailings.

We greatly appreciate your understanding in the abovementioned indexation and we thank you for your ongoing support in the valuable work that LIBER is doing.
